Concluding declarations

1. I have neither been banned from studying at a German university due to regulatory proceedings (such as criminal proceedings) nor have such proceedings ever been initiated against me.
2. I have never had any of my mandatory coursework, or mandatory examinations, in the chosen degree program assessed as "definitively failed" either at another university within the scope of the Framework Act for Higher Education (Hochschulrahmengesetz – HRG) or at a university in a member state of the European Union or in another signatory state to the Agreement on the European Economic Area.
3. I authorize Technische Universität Berlin to use my exercise, seminar and examination papers for teaching and research purposes and to publish them.
4. I am aware that as a student of a Berlin university my habitual residence is deemed to be in the catchment area of the university. Pursuant to Section 10 (6) sentence 1a of the Berlin State Higher Education Act (Berliner Hochschulgesetz – BerlHG), the catchment area is deemed to consist of the federal states of Berlin and Brandenburg. In accordance with the Federal Act on Registration (Bundesmeldegesetz – BMG), as amended from time to time, I am therefore required to register my habitual residence with the authorities in the university's catchment area. I undertake to inform TU Berlin of any change in my address by updating my personal data in tuPORT.

In this regard, I am aware that any violation of the obligation to register may be penalized with a fine according to the Federal Registration Act.

Students registered at another university and doctoral students are exempt from this regulation. Students whose degree programs do not require them to live in the catchment area for the duration of their studies (such as those pursuing extra-occupational master's studies) are likewise exempt.

5. I am aware that, as a non-German citizen, I must be in possession of a valid residence permit – to be applied for at the Berlin Registration Office for Foreigners – in order to enroll at TU Berlin.

In the event of missing or incomplete documents, TU Berlin is not obliged of its own motion to investigate the facts of the case. We therefore ask you to ensure that all information and documents are submitted in full. The University will also not of its own motion request missing or incorrect documents.

Additional declaration for applicants with an ECTS certificate

Allowing students to enroll under reserve of revocation – that is, with an ECTS certificate – is a concession on the part of TU Berlin. In accordance with Section 22 (2) Ordnung zur Regelung des allgemeinen Studien- und Prüfungsverfahrens an der Technischen Universität Berlin – AllgStuPO, applicants are expected within the first degree semester of the master's program to provide the Graduate Admissions Office with evidence of having acquired their first university degree qualifying them for a profession.

Should you be unable to do so as a result of circumstances beyond your control, you may apply during the first degree semester for a one-time extension for a further semester. No further extensions are then possible.

The form to apply for an extension to enroll for a master's program under reserve of revocation (as per Section 24 (4) AllgStuPO) is available via your TUB account (tuPORT) at "My applications".

Should you, however, not be granted an extension, you will be ex-matriculated from the master's program and will need to reapply as a re-registrant. When doing so, you may only apply for the next higher degree semesters. When applying as a re-registrant for the next-higher or higher degree semester in a master's program with restricted admission, you are additionally required to provide proof of sufficient academic performance to qualify for this particular semester (30 ECTS per completed degree semester).

It is not possible to re-enroll if you are not able to complete the program within the standard period of study.

Enrollment under reserve of revocation is only possible for master's programs.

It is not possible to be assigned to a higher degree semester during the period of enrollment under reserve of revocation (as per Section 22 (4) AllgStuPO).

Likewise, in the case of enrollment under reserve of revocation, the master's program may not be studied part-time.
