You will be ex-matriculated ex officio, in accordance with Section 15 sentence 2 no. 3 of the Berlin State Higher Education Act (BerlHG) unless you can provide sufficient reason for your continued enrollment within two months. Please note the deadlines for application and enrollment.

It is not possible to re-register for the above-mentioned degree program for the coming semester. Should you have already re-registered for the coming semester and are not continuing your studies in another degree program at TU Berlin, your re-registration will be revoked pursuant to Section 49 (2) no. 3 Administrative Procedures Act (VwVfG) in the version of the announcement of 23 January 2003

(Federal Gazette I p. 102) last amended by Article 11 (2) of the Act of 18 July 2017 (Federal Gazette I p. 2745).

Any fees you have already paid can be partially refunded to you. Your student ID is the property of TU Berlin and as such is to be returned to the Campus Center either in person or by post at the end of the current semester. Action against this decision may be brought before the Administrative Court of Berlin.

This must be filed within one month of notification of the decision, either in writing to the Verwaltungsgericht Berlin, Kirchstr. 7, 10557 Berlin, or dictated in person to the clerk of the court (Urkundsbeamter), or via an electronic document as per Section 55a of the Code of Administrative Court Procedure.

Please be aware that in the case of written or electronic filing of an action, the date on which the Berlin Administrative Court receives the action determines whether the aforementioned deadline for filing an action has been met or not.
